## AUTHORIZING T&M ASSOCIATES TO SOLICIT BIDS FOR THE 2024 SEWAGE COLLECTION SYSTEM REHABILITATION – PHASE 2

WHEREAS, the Authority engineer has recommended that the Authority undertake to correct defects and perform rehabilitative repairs to sewage collection system; and

WHEREAS, the proposed rehabilitation will be completed in three (3) phases, with Phase 2 involving (a) the installation of 2,965 LF of 8" CIPP sewer rehabilitation lining; and (b) restore and seal 15 sanitary sewer manholes and benches at the Circle Pump Station and on Marin Way and Brookwood Drive; and

WHEREAS, the Authority Engineer has submitted a proposal dated August 5, 2024 for engineering, design, contract administration and construction observation services; and

WHEREAS, the Authority Engineer has set forth the work that is required and an estimate of the amount therefore of not to exceed \$52,400.00 in preparation of pre-design and design services, bid documents & bidding, contract administration and inspection; and

WHEREAS, in the event the Authority opts to perform all site inspection of the lining and manhole rehabilitation, the estimate contained in the August 5, 2024 proposal shall be reduced by \$6,300.00; and

WHEREAS, it has been determined that the upgrades to the sewage collection system would be in the best interests of the Authority.

NOW, THEREFORE, BE IT RESOLVED, by the Eatontown Sewerage Authority, as follows:

1. That T&M Associates is authorized to prepare a construction plan, utilizing the existing Authority sewer mapping, for (a) the installation of 2,965 LF of 8" CIPP sewer rehabilitation lining; and (b) restore and seal 15 sanitary sewer manholes and benches at the Circle Pump Station and on Marin Way and Brookwood Drive.

- 2. That T&M Associates prepare bid specifications and solicit bids for the contract.
- 3. That T&M Associates shall receive and review all bids and provide a recommendation of award letter.
- 4. That T&M Associates shall be paid a fee of not to exceed \$52,400.00 for its services provided; \$21,600.00 for design work, \$8,500.00 for preparation of the bid documents and bidding process, \$22,250.00 for design work and \$22,300.00 for contract administration and construction observation.

**BE IT FURTHER RESOLVED** that the Executive Director is authorized to execute any and all documents necessary to effectuate this resolution.
