WHEREAS, the benefits of this agreement would be (a) the City of Asbury Park, via its fire department, will provide emergency response capabilities with trained/equipped members for any technical rescue incidents, accidents, etc., involving Authority employees/equipment/locations; (b) the City of Asbury Park Fire Department would be the designated rescue service for permit-required confined spaces in Authority locations; and (c) the City of Asbury Park Fire Department will drill, at a minimum, one time per year on-site at Authority locations, in coordination with Authority management; and

WHEREAS, the agreement will be for a term of January 1, 2024 through December 31, 2026 at the rate of \$18,400.00 for the first year, with a 2.5% year-to-year increase each year thereafter; and

WHEREAS, it is in the best interests of the Authority to continue said agreement for the storage of the scanned documents.

NOW, THEREFORE, BE IT RESOLVED, by the Eatontown Sewerage Authority, as follows:

That the Authority shall entered into a shared services agreement with the City of Asbury
 Park for Technical Rescue Services.

- 2. That the shared services agreement between the Authority and the City of Asbury Park shall commence January 1, 2024 and continue through December 31, 2026.
- 3. That the total amount paid to the City of Asbury Park in accordance with the terms and conditions of the shared services agreement is \$18,400.00 for the year 2024; with a 2.5% year to year increase thereafter.
