RESOLUTION AWARDING CONTRACT AND RATIFYING ACTIONS FOR THE PURCHASE OF SULZER XFP PUMP REPLACEMENT THROUGH PARTICIPATION IN THE PVSC COOPERATIVE PRICING SYSTEM

WHEREAS, the Eatontown Sewerage Authority (the "Authority"), Borough of Eatontown, County of Monmouth, is in need for a replacement Sulzer XFP Pump and associated equipment; and

WHEREAS, the Authority, as a contracting unit, may without advertising for bids, purchase goods and services entered into on its behalf by the Passaic Valley Sewerage Commission ("PVSC") Pricing System, pursuant to the provisions of P.L. 2011, c.139, which permits contracting units to use contracts awarded by national or regional cooperatives or other states that were competitively bid; and

WHEREAS, c ("Reiner"), having an address of 53 US Highway 206, Stanhope, NJ 07874, has been awarded a contract for one (1) Sulzer XFP Pump Replacement and associated equipment; and

WHEREAS, under PVSC contract # B364-4, Reiner is an authorized vendor that can provide a Sulzer XFP Pump to the Authority, directly or by authorized reseller, at a cost not to exceed \$8,263.00; and

WHEREAS, the Authority desires to award the contract to Reiner for one (1) Sulzer XFP Pump and associated equipment; and

WHEREAS, in accordance with N.J.S.A. 5:30-5.4(a)(3), the Authority certifies the availability of funds to cover the maximum dollar value of the pending contract as set forth in the Resolution.c

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Eatontown Sewerage Authority that:

- 1. The Authority does hereby authorize that Reiner Pump Systems, Inc. under PVSC contract # B364-4, be utilized to provide one (1) Sulzer XFP Pump and associated equipment to the Authority at a cost not to exceed \$8,263.00.
- 2. The Authority does hereby further ratify any prior actions taken to advance the order of the Sulzer XFP Pump from Reiner Pump Systems, Inc. pursuant to the PVSC contract.
- 3. The Authority's Executive Director, Authority Attorney or any other official, officer or employee of the Authority be and they are hereby authorized to execute any and all documents and to take any and all actions necessary to complete and realize the intent and purpose of this Resolution.
