## **RESOLUTION NO. 2025-03-04**

## AMENDING RESOLUTION 2024-12-03, RESOLUTION 2024-12-04, AND RESOLUTION 2024-12-05 TO MODIFY CONTRACT TERMS TO TWO (2) YEARS

WHEREAS, the Eatontown Sewerage Authority (the "Authority"), Borough of Eatontown, County of Monmouth, desires to amend resolutions to modify the contract terms from three (3) years to two (2) years, pursuant to law; and

WHEREAS, on or about December 10, 2024, the Authority adopted the following resolutions, which included contract terms of three (3) years:

- 1. Resolution 2024-12-03: Awarding Contract for Emergency Repairs of Sanitary Sewer Cleaning and Lining Under the Sanitary Sewer Force Account (2025-2028) to National Water Main Cleaning Company
- 2. Resolution 2024-12-04: Awarding Contract for Emergency Repairs of Sewer Connections and Mains Under the Sanitary Sewer Force Account (2025) to J.Fletcher Creamer & Son, Inc.
- 3. Resolution 2024-12-05: Awarding Contract for Pump Station Maintenance Force Account (2025-2028) to Municipal Maintenance Co.

WHEREAS, pursuant to N.J.S.A. 40A:11-15 of the New Jersey Local Public Contracts Law, all contracts for the provision or performance of goods or services shall be awarded for a period up to two (2) years, with limited exceptions; and

WHEREAS, the services to be provided in the above-referenced resolutions do not qualify for an exception to the two (2) year duration limitation of N.J.S.A. 40A:11-15; and

WHEREAS, based on the foregoing, the Authority desires to amend the above-referenced resolutions to comply with the duration limitations of the Local Public Contracts Law.

**NOW THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Eatontown Sewerage Authority that:

- 1. The aforesaid recitals are incorporated herein as though fully set forth at length.
- 2. The Authority does hereby amend Resolution 2024-12-03, Resolution 2024-12-04, and Resolution 2024-12-05 to modify the contract terms from three (3) years to a maximum of two (2) years, pursuant to N.J.S.A. 40A:11-15.
- 3. The Authority's Executive Director, Authority Attorney or any other official, officer or employee of the Authority be and they are hereby authorized to execute any and all documents and to take any and all actions necessary to complete and realize the intent and purpose of this Resolution.
- 4. This Resolution shall take effect immediately.
